### Request to grant asylum to Ruta of Godland, aka Ruta Rietuma

We beg You to stop the illegal proceedings of extradition of Ruta to Latvia as these business companies that pretend to be state and justice authorities do not represent state Latvian Republic, as they are Duns & Bradstreet DNB.com Jesuit businesses, fast found on UPIK.de. They are specicide-war criminals, who are drug lords and run secret Mind Control technic projects, victimizing Ruta. They have no right to issue arrest orders on peaceful indigenous people and patriot citisens. The criminals have occupied the systems conditioning the courts to be megathieves. They have robbed Ruta and her family of all her indigenous heritage, and have made Ruta to live homeless life, they have 2016 through Nordea stolen her familie's farm in Latvia, where Latvian society, the base of Latvian state was registered, and have thrown Ruta out of dusins of appartments etc. Ruta Rietumas fathers mother Biruta Lepste is the last Livi of Livland language speaking woman of the Lepste kin. This is genocide of Livi, Livonians, Svearnas, ViKings etc. Rutas mothers mothers name is Erna Uzule, a very rare name mate of Iron Erna.

Ruta was born in Latvia and has grown up in Sweden, where she returned, but was refused housing though 13 years in the appartment que in Haninge kommun, as 3d world refugees have privileges.

Ruta Rietuma decided to search refuge i Norway. She met the Social service officer in Bergen Arstad - Inger Hagland. Though Ruta has Norwegian personal code 25018926493, she was refused assistance for living arrangements, 4<sup>th</sup> coutry refusing home. This resulted in further difficulties such as getting medication, due to lack of address. Which led to psychosis and hospitalization in Bergen.

The illegal active haunt for the living fertile indigenous woman has been ongoing for 4 long months since United States private business in Sweden - Åklagarmyndigheten - with DUNS nr 350580502, VD Niklas Johansson, received a request from United States private business in Latvia fraudulently called Latvijas Republika Prokuratura with DUNS nr 681829609. Most likely now is the United States business company Den Høyere Påtalemyndighet with DUNS nr 730742657 getting to handle

the human trafficking business between Norway and Latvia, within sames syndicate of Vatican world DNB.com tyrant empire.

Södertörns Tingsrätt rådman told on video to Ruta that Södertörns Tingsrätt does not have any contract with any state authority, link on next page. A treasonous fraud is that Sveriges Domstolar are private foreign businesses, working for Vaticans The Crowns Bar association, conducting stealth of land and property, imposing slavery and human trafficking, and overall Evils.

It has always been illegal to terrorize psychiatrically ill people. Far more so as the terrorist companies work with covert Mind Control institutes and make targets ill 24/7. Nowadays and in Rutas case **international EU arrest order** was used to assist terrorism/inquisition.

Each minute now is a terrorist attack on mentally wounded Ruta, who in great fear took decision to escape alone the human traffickers (at U.S. Polismyndigheten DUNS nr 350580494, business company CEO Staffan Käll in Sweden) and had to survive alone to save herself in unknown hostile environment. Milliards others are though in her homeless situation, as long as these terrorist institutions are falsely taken to be authorities, running all from people stolen housing facilities! There is nowhere to hide! If we continue to accept this, humanity is doomed to experience specicide. Ruta chose to search refuge in Norway, where she had worked.

Latvia is Rutas birth country of origin. Latvia is an occupied country – even through Norwegian corporations, that are transnational, and controlled by Deep State of NOW, which ensures that even Norway is occupied. One million fertile people have left Latvia for the last 25 years, to survive. There are around 1,5 million left. There are no state banks in Latvia – there is no sovereign state, neither in Latvia or Norway. Even Norwegian DNB Luminor etc is involved in war crimes against Latvians, who expected Norwegians to be better than Russians, but death camps are now all cities of the world.

Ruta lives to have family and children. Save the last fertile Europeans! May it be so!

Ruta is an alive fertile ViKing Livi Livonian Swea woman who has been left without a home, a safe shelter, all of her grown up life. She has already 2009 been handicapped by regime that administrates occupied Latvia. She has never ever been provided housing by the states of her citizenship – Latvia and Sweden.

January 2019 an unverified investigator Leticia Servantes, addressed Rutas mother on Latvian IT <a href="https://www.draugiem.lv/user/3658703/">https://www.draugiem.lv/user/3658703/</a> platform to investigate where is Ruta. Mother asked Leticia to verify herself and the structures she represents, that Ruta is in rehabilitation and is a victim of administrative warfare against indigenous people and citisens of state Latvian Republic. Leticia Servantes did not verify neither herself nor the structures she represented. She wrote that Ruta will be punished and blocked her profile.

It is of importance that occupying forces of foreigners have no right to judge and hunt indigenous people and citisens of state Latvian Republic. It is enough to know her Spanish name Leticia

Servantes to dismiss the hunt she started, even less an international hunt on a peaceful woman Ruta, with goal of doing business – human trafficking business, that has been now authorized by NWO Deep State business company ÅKLGARMYNDIGHETEN.

Suddenly on the 19<sup>th</sup> of July serious polise troops arrived to Ditta apartment in Jordbro Sweden without arrest order or house-check-orders and started hunting Ruta. It ended with her being arrested by 7 armed policemen. We went to POLISMYNDIGHETEN in Haninge. Nobody verified their organisations to have state and community authority licences, video. Because all Polise manufactured ID cards are owned by private foreign business companies, registered on DNB.com, as the ID for souls owned by the death camp owners who run Vatican and UN. Godland have started issuance of real ID cards of state Konungariket Sverige and we have demanded SKATTEVERKET to reorganize their structures under leadership of Indigenous king Leif I, attached document.

After stating 23.08.19 in Södertörns Tingsrätt that it is a documented fact that Ruta is mentally ill, both women pretending to be Swedish judge and prosecutor, decided to arrest Ruta, for a 3 year old story from 2016 in Riga where young woman Ruta under severe psykosis, thrown out of her apartment, by occupying forces, tried to get 3 dresses in a Riga shop, and violently scratched the hand of the saleswoman.

Nobody was raising the issues that Ruta has been poisoned and Mind Controled since 2009, when government was officially selling chemical drugs on streets of Riga, that her Livonian heritage of lands and properties has been stolen from her, that her shares in the state stock have never been payed to her, that she is the biggest asset the state has – a fertile woman that has to be protected and cherished, as she can provide the holy babies, that most sterilized people cant!

Rutas family had never encouraged her to stealth, and Ruta says that it was the voices of Mind Controle that made her do that, which was unthinkable in their family. But analyzing the event, theoretically and historically, Ruta of Godland could have had any right to collect taxes on the lands of her Livi predecessors, that Riga stands upon, and it is quite funny that her psykosys or Mind Controle villains made her urge and want 3 dresses – as if for herself, her syster and her mother, so they would not stand poor and naked in the middle of their lands, that were being pirated by the The Crown corporation tax collectors, massacring Latvian people and driving most of the fertile population out of their occupied lands. Such very expensive dresses were nothing Latvians could buy, they only made them for invader foreigner tourists. Nobody answered neither Rutas nor her mothers, nor the prosecutors of Baltic Sea Indigenous Court letters asking questions to business company Södertörns Tingsrätt and Åklagarmyndigheten on verifying what authority and jurisdiction they have to prosecute citisens of Kingdom of Sweden and state Latvian Republic, and demanding that indigenous peoples rights of Godland are met.

Ruta went to the proceedings 16.8.19, but they were cancelled and postponed. But while in the building of the company Södertörns Tingsrätt, Ruta heard the answer from the council representative that so called court does not have any agreements within the state Kingdom of Sweden. By which it became clear that Södertörn Tingsrätt has no legitimate authority to hold court on citisens of state Kingdom of Sweden.

The question on the contracts with the state and demand to present employment contracts to the court was unlawfully neglected even on the day of court 23.08.19. The war crimes fraud committing business women of UN and Vatican syndicates, pretending to be a state judge, and a prosecutor, and the man pretending to be a state lawyer, all three of them refused to show their assignment agreements with the court and existing contracts with state Kingdom of Sweden. All of them were obviously operating in private capacity for a foreign Vatican business company The Crown that runs DNB.com and were not in a capacity of national constitutional judge, constitutional prosecutor or constitutional lawyer. The fact that Vaticans UN The Crown mega-syndicate-corporation is being overtaken by China, and is not her majesties Queen Elisabeths company, further complicates the war crime matter. The scope of the fraud of unconstitutional authority crimes reaches specicide levels as The Crown, Deep State has swallowed all of the corporations of the western world, which is an unprecedented level of war crimes.

### Ruta applies for asylum in Norway

In October, Ditta of Godland, on behalf of her daughter, even visited the Immigration office in Bergen and was refused to leave to chief Elle Cooper the Asyl/Soknad om oppholdstilatelse for her hunted and without housing left daughter, attached here. Rutas case is conceptualy similar to the case of Neringa Venckiene who was unjustly extradited from USA after persecuted by the Roman business syndicate in Lithuania involved in human trafficking of her neise Deimante. As human traffickers are after Rutas son Anton. Ruta has been working and living in Norway though.

### **Demands of Justice**

We demand every authority to be verified and validated, with proof of existence of contracts with indigenous societies and citizen state councils, that have given oath to serve them. Here is where we draw the line. The state citizen property is stolen by these war waging DNB.com owner business companies! Who are war waging terrorists, not the authority!

Ruta Rietuma shall not be transported to by indigenous people unverified and hostile agressive forces, who have occupied indigenous lands and are committing genocide in Latvia. If You let her into the hands of Noahid inquisition, Norway will be guilty of reparations and compensations. ### IWOCG has decided following solutions to the structural war crimes of any state corporatisation and weaponisation against its citisens

Through corporatization the main systems of society, that have been its pillars for thousands of years, have been hit out of the base of its foundation and brought into the illegitimate power of invisible hand – called New World Order, or Deep State, Vatican or UN.

The most important such pillars now differ from 1809: § 6. 1809: Stats-Secreterare skola wara Fyra, nemligen: En för Krigs-Ärender; En för Cameral- Landthushållnings- Bergshandterings- samt andre dermed gemenskap ägande Inrikes Civile-Ärender; En för mål rörande Drätzel-Werket, In- och Utrikes Handeln och Slöjderne, samt En för Ärender, som angå Religionen, Ecclesiastique-Werket, Allmänna Upfostran och den offenteliga Fattigwården.
